MAGISTRATES COURT

M1A – Initial grant

M1AC - Evidence at Committal

- **Application for evidence to be taken at Committal Hearing**

This grant covers counsel's work in relation to an application for evidence to be taken at Committal Hearing in the Magistrates Court.

An extension of aid should be sought via LA Grants 2.0 before further assistance will be provided.

FAMILY

FAMILY LAW EXTENSION NOTES

Family Law Filing Fees

Family Law grants do not cover payment of court fees. This is because Commonwealth Government policy is that these fees should be the responsibility of the legally assisted client. There is one exception and that is fees for filing consent orders. Such fees are covered by the grant of assistance. Solicitors should apply for a reduction of the filing fee, and for payment of the fee to be deferred or waived. Applications for fee reductions, deferral or waiver are included in the scope of work covered by the grant of legal assistance and do not attract additional remuneration.

Solicitors should advise legally assisted clients that any fee that remains unpaid after the date specified for payment, is recoverable from the legally assisted client as a debt due to the Commonwealth.

EQUITABLE BRIEFING CLAUSE (EBC)

Legal Aid ACT supports the ACT Law Society and Barr Association's Equitable Briefing Policy, located on their website at www.actbar.com.au. Solicitors with aid to brief counsel are encouraged to read this policy and to apply it when selecting counsel to be briefed in a family law matter.

FEDERAL CIRCUIT AND FAMILY COURT

F1 – Stage 1: Initial Grant, Investigate and Report (Solicitor only)

This initial grant covers legal costs associated with the taking of instructions, providing initial legal advice and determining how the matter should best proceed (eg, advice only or next steps to be FDR or litigation to initiate or to respond to proceedings). A reporting letter to Legal Aid ACT is required, including if an extension of aid is sought after the I&R grant.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's prospects of success. Extension requests for undertaking further work on a matter upon the completion of I&R will not be considered unless seeking an extension of aid for up to four hours of further limited legal assistance, FDR or litigation.

F1A – Stage 1: Further Limited Legal Assistance (Solicitor only)

This grant covers legal assistance in circumstances where it is not appropriate to progress the client's matter to FDR or litigation for a parenting or property matter AND it can be demonstrated that further limited legal advice/assistance beyond the initial I&R stage, is necessary to assist the client to resolve significant issues related to their circumstances of family separation.

Examples might include further advice for a victim of family violence who is experiencing changing circumstances (eg, homelessness, victim of crime and other party incarcerated or changing bail conditions) and the client has been advised not to initiate FDR or Court proceedings. The client may benefit from retaining a lawyer for further advice and referral to support agencies, during a period of rapidly changing circumstances. Another example might be a client needing advice about self-representation in relation to Contravention proceedings (eg, advice about whether FDR is required by the Rules, what Court forms to file, the Court process, whether to file affidavit and if so, what information to include). This grant can be used for clients in circumstances where Legal Aid ACT does not provide ongoing funding for representation (eg, Contravention and other enforcement proceedings, child support and parentage testing matters). This grant can only be used for further legal advice for up to four hours following the completion of an I&R grant. This grant cannot be used to prepare Court documents or to represent a client in any Court proceedings.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's prospects of success.

Solicitor's costs: \$160 (per hour for up to four hours)

F2A – Stage 2: FDR early intervention (no court proceedings) (Solicitor only)

This early intervention FDR grant is for matters that are not being litigated in the Court process. The clause covers legal costs associated with taking instructions, providing legal advice and preparing a client for FDR (eg, the intake and assessment process). It includes representing a client in a FDR conference and preparing a Parenting Plan or Consent Orders (whether this is completed during or after the FDR conference). A F2b(i) grant may also be applied for on LA Grant in addition to this F2A clause in early intervention property FDR matters.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's current family circumstances and prospects of success for orders sought.

Solicitor's costs: \$800

F2B – Stage 2: FDR early litigation intervention (at any stage of court proceedings) (Solicitor only)

This litigation FDR grant is for Court matters. The clause covers legal costs associated with taking instructions, providing legal advice and preparing documents for FDR in accordance with Family Law Rules (eg, Confidential Case outline document and Minute of Orders Sought). It includes preparing and representing a client in a FDR conference and drafting a Parenting Plan, Interim or Final Consent Orders during the conference.

NOTE: In litigation property FDR matters, A F2C grant may also be applied for on LA Grants 2.0 in addition to this F2B clause. In litigation parenting FDR matters, A F2B(i) grant may also be applied for in addition to this F2B clause in relation to matters that settle on a final basis.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's current family circumstances and prospects of success for orders sought.

Solicitor's costs: \$960

F2B(i) – Finalising a matter that has settled with Final Consent Orders after a litigation FDR conference or other negotiations (Solicitor only)

This finalising a matter after an FDR grant is for parenting and property litigation matters only - where a FDR conference or other negotiations (including a Conciliation Conference for property matters) results in a final settlement enabling the matter to be removed from the Court's list of pending cases. The grant covers legal costs associated with finalising and settling Final Consent Orders, preparing associated Court forms in accordance with relevant Family Law Rules, filing documents with the Court and if appropriate, contacting the Court to request orders be made in Chambers and that any outstanding court dates be vacated and the matter removed from the Court's list of pending cases.

Solicitor's costs: \$320

F2C – Stage 2: Financial Disclosure and exchange pre-property FDR (Solicitor only)

This financial disclosure and exchange pre-property FDR grant is for both litigation and non-litigation property FDR matters, including matters listed for a Court Conciliation Conference. The clause covers legal costs associated with completing financial exchange in preparation for a property FDR Conference or Court Conciliation Conference in accordance with any relevant Family Law Rules.

NOTE: This grant can be requested on LA Grants 2.0 in addition to a F2A grant (FDR early intervention) or F2B grant (FDR litigation intervention) or F3F grant (Court Conciliation Conference) for the purpose of property matters only.

Solicitor's costs: \$160 (per hour for up to four hours)

This litigation FDR grant is only for Court Ordered FDR at Court with a Registrar and Family Consultant of the FCAFCOA. The clause covers legal costs associated with taking instructions, providing legal advice and preparing a client for FDR in accordance with Family Law Rules. It includes representing a client in a Court FDR conference with a Registrar and Family Consultant and it includes drafting a Parenting Plan, Interim or Final Consent Orders during the conference.

NOTE: Part A of the conference is scheduled by the Court for two hours and includes solicitors and parties and Part B of the conference is scheduled by the Court for a longer duration (up to a day) and includes solicitors and parties and the ICL (if one has been appointed).

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's current family circumstances and prospects of success for orders sought.

[F3A – Stage 3: Initiating or Responding to Court Proceedings seeking interim and final orders \(including applications seeking orders for return of child/recovery orders and Family Law Airport Watch List orders\) \(Solicitor only\)](#)

This grant covers work in relation to taking instructions, providing legal advice, drafting, filing, and arranging service of Court documents (eg, initiating application or response application and affidavit). The clause also covers representing the client at the 1st court event before a Judicial Registrar Return list and to represent the client at the 1st defended interim hearing.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's current family circumstances and prospects of success for orders sought.

Solicitor's costs: \$1,600

F3B – Stage 3: Initiating or Responding to Court Proceedings seeking final orders only (Solicitor only)

This grant covers work in relation to taking instructions, providing legal advice, drafting, filing and arranging service of Court documents in an application or response that seeks Final Orders only (eg, where no affidavit is required until matter listed for a final hearing). An example might include an application for property settlement where no interim orders are sought (eg, no interim orders sought for spousal maintenance or sole occupation of the marital home).

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's current family circumstances and prospects of success for orders sought.

Solicitor's costs: \$800

F3C – Stage 3: Application in Proceedings for further Defended Interim Hearing (solicitor only)

This grant covers work in relation to taking instructions, providing legal advice, drafting and/or reviewing subpoena material, drafting, filing and arranging service of Court documents (eg, Application in Proceedings and Affidavit) to initiate or respond to an application that seeks to bring a matter back before the Court for further Interim Hearing. This clause also covers representing the client at a mention in relation to the application and/or at the Interim Hearing in relation to the application.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's current family circumstances and prospects of success for orders sought.

Solicitor's costs: \$1,440

F3D – Stage 3: Further Mentions before Judicial Registrar or Judge (solicitor only)

This grant covers work for preparing and representing a client in Court for a Mention – after the first Mention and/or the first Interim Hearing of the Matter. An example might include a Directions Mention that lists a matter for final hearing or a Mention before a Judicial Registrar for the purpose of reviewing the current status of a matter and appropriately progressing to next stage of Court process.

This grant cannot be used in addition to a F3A grant (initiating or responding to proceedings) or F3C grant (application in proceedings) because these clauses cover costs for appearance at a Mention.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's current family circumstances and prospects of success for orders sought.

Solicitor's costs: \$480

F3E – Stage 3: Ongoing interim advice and negotiations (solicitor only)

This grant covers work for taking instructions, providing legal advice and conducting negotiations that resolve substantial interim issues or result in settling the matter on an interim or final basis. Advice and negotiations might include verbal or written communications (telephone, letters, emails). This grant will not be approved for advice and negotiations of a longer duration than 2 hours. This is because in these circumstances, solicitors should consider further FDR where there are good prospects of success of the parties being able to reach agreement.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an outline of work to be undertaken and a current assessment of the matter.

Solicitor's costs: \$160 (per hour for up to two hours)

F3F – Stage 3 : Property Court Conciliation Conference (Solicitor only)

This new grant covers legal costs associated with taking instructions, providing legal advice, preparing and representing a client in a Court Conciliation Conference for property matters. It includes preparing Final Consent Orders during the Conciliation Conference.

NOTE: This grant can be requested on LA Grants 2.0 in addition to a F2C grant (Financial Disclosure and Exchange pre property FDR)

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's current family circumstances and prospects of success for orders sought.

Solicitor's costs: \$960

F3G – Stage 3: Preparing Terms of Reference for Expert Report (Solicitor only)

This grant covers legal costs associated with providing legal advice, negotiations, drafting and settling terms of reference for a Court ordered expert report.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's current family circumstances and prospects of success for orders sought.

Solicitor's costs: \$360

F3H – Stage 3 - Family, Expert and other Court Ordered Reports (Solicitor only)

This grant covers preparing a client for interviews in relation to Family, Expert Report and other Court ordered reports; reading the report; advising client in relation to the report and any of its recommendations and if appropriate, preparing consent orders.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0. All extension requests must be supported by a detailed reporting letter that includes an assessment of the client's current family circumstances and prospects of success for orders sought.

Solicitor's costs: \$480

F3I – Independent Children’s Lawyer (ICL) (solicitor only)

This grant covers the Court’s initial appointment of the Independent Children’s Lawyer (ICL) and at this stage, covers professional costs only. If ICL needs to subpoena material or form the view that an expert report is required in the matter, the ICL needs to request an extension of aid for the appropriate grant.

At this initial stage the ICL must advise the parties, or their solicitors, that Legal Aid ACT will be seeking reimbursement of the entire costs of the ICL. Costs must be sought in all matters where:

1. There has been two separate appearances in Court by the ICL; or
2. There has been an appearance in Court by the ICL for interim hearing; or
3. There has been an attendance by the ICL at a Legal Aid ACT Family Dispute Resolution (FDR) conference or a Court Ordered FDR conference with a Registrar.

Costs are to be sought in the usual course of events at the conclusion of a Final Hearing. However, the ICL also has discretion to seek costs following any interim event. In accordance with S117(4) costs should not be sought against a legally aided party.

The ICL has limited discretion to waive the requirement to seek costs. Discretion may be exercised where the ICL is of the opinion that the issue of costs forms a significant barrier to the final settlement of the matter. If the ICL determines not to seek costs they are required to provide a written report to the Legal Aid ACT Client Services Manager which outlines the circumstances of the case, including an explanation as to why the matter could not have settled on a final basis with the costs of the ICL to be left as a matter that could be judicially determined.

The ICL may seek costs either in accordance with the relevant schedule of Court fees or the current amount committed on the grant assigned by Legal Aid ACT. The current commitment amount of any grant is available on the LA Grants 2.0 dashboard. This amount can be verified at any time by contacting Client Services and providing the ICL grant file number.

Costs sought which are provided either voluntarily or by way of a Court Order are to be paid to Legal Aid ACT via its business operating account with the ICL grant number provided with the payment. Client Services can be contacted for further details.

Solicitor’s costs: \$1,920

F4 – Stage 4: Preparation for Final Hearing - parenting only or property only (solicitor)

This grant covers costs associated with preparing a family law parenting only or property only matter for final hearing. Work includes taking instructions; reviewing materials from other parties, providing legal advice; drafting and/or reviewing subpoena material and other Court documents in accordance with Family Law Rules including a final affidavit, case outline and Minute of Final Orders Sought etc; interviewing witnesses and drafting witness affidavits.

Requesting aid for funding for preparation and representation at a Final Hearing cannot be approved without a detailed reporting letter that includes: information about current interim orders in relation to the client; an assessment of the client's current family circumstances and prospects of success in relation to final orders sought; and assessment of the client's position in relation to any recommendations of a final Family or Expert Report or other significant report in relation to the matter.

Solicitor's costs: \$1,760

F4(i) – Stage 4: Preparation for Final Hearing - parenting and property (solicitor)

This grant covers costs associated with preparing a family law parenting and property matter for final hearing. Work includes taking instructions; reviewing materials from other parties, providing legal advice; drafting and/or reviewing subpoena material and other Court documents in accordance with Family Law Rules including a final affidavit, case outline and Minute of Final Orders Sought etc; interviewing witnesses and drafting witness affidavits.

Requesting aid for funding for preparation and representation at a Final Hearing cannot be approved without a detailed reporting letter includes: information about current interim orders in relation to the client; an assessment of the client's current family circumstances and prospects of success in relation to final orders sought; and assessment of the client's position in relation to any recommendations of a final Family or Expert Report or other significant report in relation to the matter.

Solicitor's costs: \$2,240

F4(ii) – Stage 4: Preparation for Final Hearing when briefing Counsel – parenting only or property only (solicitor)

This grant covers costs associated with preparing a family law matter for final hearing when briefing Counsel. Work includes taking instructions; reviewing materials from other parties, providing legal advice; drafting and/or reviewing subpoena material and other Court documents in accordance with Family Law Rules including a final affidavit, case outline and Minute of Final Orders Sought etc; interviewing witnesses and drafting witness affidavits. When counsel is briefed this grant also covers the cost of preparing and delivering a brief to counsel and initial conference with counsel.

Requesting aid for funding for preparation and representation at a Final Hearing cannot be approved without a detailed reporting letter that includes: information about current interim orders in relation to the client; an assessment of the client's current family circumstances and prospects of success in relation to final orders sought; and assessment of the client's position in relation to any recommendations of a final Family or Expert Report or other significant report in relation to the matter.

Solicitor's costs: \$2,240

F4(iii) – Stage 4: Preparation for Final Hearing when briefing Counsel – parenting and property (solicitor)

This grant covers costs associated with preparing a family law parenting and property matter for final hearing when briefing Counsel. Work includes taking instructions; reviewing materials from other parties, providing legal advice; drafting and/or reviewing subpoena material and other Court documents in accordance with Family Law Rules including a final affidavit, case outline and Minute of Final Orders Sought etc; interviewing witnesses and drafting witness affidavits. When counsel is briefed this grant also covers the cost of preparing and delivering a brief to counsel and initial conference with counsel.

Requesting aid for funding for preparation and representation at a Final Hearing cannot be approved without a detailed reporting letter that includes: information about current interim orders in relation to the client; an assessment of the client's current family circumstances and prospects of success in relation to final orders sought; and assessment of the client's position in relation to any recommendations of a final Family or Expert Report or other significant report in relation to the matter.

Solicitor's costs: \$2,720

F5A – Stage 5: Final Hearing each day (solicitor only)

This grant covers one day of final hearing where a solicitor is conducting the hearing.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0.

Solicitor's costs: \$1,240

F5B – Stage 5: Final Hearing additional half day (solicitor only)

This grant covers an additional half day where a solicitor is conducting the hearing.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0.

Solicitor's costs: \$620

F5C – Stage 5: Un defended short Final Hearing (solicitor only)

This grant covers a half day final hearing in circumstances where the solicitor is conducting the hearing and the matter is being heard on an undefended basis (which can take less than half a day).

NOTE: This grant is not available for Counsel

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0.

Solicitor's costs: \$480

F5D – Stage 5: Preparing written Submissions for Final Hearing (Solicitor only)

This grant covers the solicitor preparing written submissions when during the Final Hearing or at its conclusion, the Court makes a direction for written submission.

No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0.

Solicitor's costs: \$620

F6A – Stage 6: Final Hearing one day (solicitor with counsel)

This grant covers one day of Final Hearing for solicitor and counsel. Costs for Counsel includes the Fee on Brief and all preparation, reading, conferences and representation at the first day of Final Hearing.

All extension requests for aid to brief Counsel for a Final Hearing must be supported by a detailed reporting letter that demonstrates the special need for counsel. Aid will not usually be approved to brief counsel for a Final Hearing that is listed for one day only or less. No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0.

This grant covers necessary chamber work that is not provided for in any other grant. It can be used in relation to interim or final hearings and may include obtaining advice from counsel in special circumstances.

All extension requests for this grant must be supported by a detailed reporting letter that demonstrates the special need for counsel and chamber work. No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0.

Counsel's costs: \$240 (per hour)

F6F – Stage 6: Short defended hearing (Solicitor with Counsel)

This grant covers work in relation to briefing Counsel for an interim or final short-defended hearing. Costs for Counsel includes the Fee on Brief and all preparation, reading, conferences and representation at the hearing. This grant will only be approved for interim hearing in exceptional circumstances (eg, a matter in Division 1 of the FCAFCOA that is hearing a complex technical issue, for example, contempt of Court with potential for incarceration of a parent).

All extension requests for this grant must be supported by a detailed reporting letter that demonstrates the special need for counsel in a short defended hearing. No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0.

Solicitor's costs: \$820

F7 – Stage 7: Receiving Judgement/explaining Orders (solicitor only)

This grant covers the solicitor's appearance in Court to receive judgement and to explain orders to the client and provide final legal advice.

Solicitor's costs: \$160

F8 – Stage 8: Outside Stage of Matter

This grant covers work undertaken that is not covered by any other grant and is supported by exceptional circumstances. An example of how it might apply could include the requirement for an exceptional volume of reading/preparation for a matter.

All extension requests for this grant must be supported by a detailed reporting letter that demonstrates the work undertaken is of exceptional circumstances and cannot be claimed under any other grant. This clause cannot be used to effectively seek payment on an hourly basis for conducting a legal aid family law matter. No further assistance can be provided without requesting and being approved an extension of aid on LA Grants 2.0.
